## Fund description and summary of investment policy

The Fund invests in a focused portfolio of African securities that are selected for their expected risk and return profile. The Fund may invest a substantial portion of the assets in a single country or region rather than a diversified portfolio of assets.

# Fund objective and benchmark

The Fund seeks to achieve the maximum US dollar total return while minimising the risk of loss within the context of an African bond fund. The benchmark is the FTSE 3 Month US T Bill + 4% Index.

# African security markets

There are numerous risks involved in investing in African security markets. These risks may be significantly higher than in more developed markets and may include (but are not limited to) the following:

- Individual countries may impose capital controls preventing the repatriation of foreign currency
- Returns are expected to be more volatile, and the average drawdown may be higher, than in more developed markets
- Low liquidity whereby subscriptions into the Fund may have to be phased in, and redemptions from the Fund may be limited per dealing day
- Market prices may not accurately reflect the fair value of a Fund asset and fair value pricing may be used

# How we aim to achieve the Fund's objective

We assess an asset's intrinsic value based on long-term fundamentals and invest where our assessment of intrinsic value exceeds the price by a margin of safety. This approach allows us to identify assets that may be out of favour with the market because of poor near-term prospects, but offer good value over the long term.



# Meeting the Fund objective

The Fund seeks to achieve the maximum US dollar return while minimising the risk of loss within the context of an African bond fund. The Fund experiences periods of underperformance in pursuit of this objective. Since inception, the Fund has outperformed its benchmark and delivered positive absolute returns in US dollars.

## Subscription and redemption charge

Investors will be charged 0.5% when subscribing for Fund shares and 0.5% when redeeming Fund shares. These charges are paid into the Fund to offset the costs associated with the transactions that are borne by the Fund. Allan Gray Bermuda Limited (the "Investment Manager") may waive these charges at its discretion, for example in the case of significant offsetting between subscriptions and redemptions.

# Annual management fee

The management fee consists of a fixed fee of 1.00% p.a.

## Total expense ratio (TER) and transaction costs

The annual management fee charged is included in the TER. The TER is a measure of the actual expenses incurred by the Fund over a one-and three-year period (annualised). Since Fund returns are quoted after deduction of these expenses, the TER should not be deducted from the published returns (refer to page 4 for further information). Transaction costs are disclosed separately.

To start the year, the highest returns within the Fund have come from its local currency investments, which now make up 25% of the Fund – up from just 16% of the Fund in mid-2024. Material to these local currency holdings are our Zambian and Egyptian debt positions. We entered our Zambian position in the last quarter of 2024 and have been adding to it since at 19% to 20% yields.

Zambia has arguably emerged from debt distress with a far lower probability of re-entering it, given that its debt burden has been haircut, and the interest bill is now manageable relative to government revenue. Encouragingly, Zambia's drought, that curtailed hydropower and caused intensive loadshedding, seems to mostly be behind it and the return of rains should see the agricultural sector rebound after a weak year. This is critical in lowering food prices and bringing down inflation from the latest print of 16.5%, thus allowing interest rates to be cut from current elevated levels. Further bolstering our investment case, Zambian copper production rose in 2024 despite a material electricity shortage due to the ability of mines to import power from the Southern African Power Pool. Several of these mines have large capital expenditure plans to boost production further – this will ultimately bleed into government revenue prospects.

The straw that broke the camel's back during Zambia's 2020 debt default was undoubtedly a shortage of foreign exchange reserves, which fell to about one month of import cover (or US\$1bn) at the time, meaning that US dollar supply was no longer sufficient to both import goods and service foreign currency debt. Reassuringly, this metric has since quadrupled to US\$4bn, representing almost five months of import cover. At the same time, newly restructured and long-dated offshore debt now carries concessional coupon rates of interest as low as 0.5% to 5.75% and can easily be serviced. Importantly, any *new* offshore debt that is raised must be done on similarly concessional terms as a safeguard against another debt derailment.

Our local currency Egyptian position consists of Treasury bills and bonds yielding between 20% and 30%. Importantly for our investment case, the Egyptian pound has been stable for over a year and foreign exchange reserves have been materially bolstered as a result of the sale of the Ras El-Hekma region in the north, International Monetary Fund disbursements and renewed foreign portfolio investor appetite. The Central Bank of Egypt's reserves should be boosted even further as foreign direct investment from the Gulf flows in over a multi-year period to develop Ras El-Hekma into a Mediterranean-style tourist resort. US dollar supply should also pick up as Egypt's Suez Canal traffic receipts normalise in the event of a sustained Gaza ceasefire and as the US attempts to impose order in the Red Sea, following months of Houthi strikes.

During the quarter, the Fund added to its Egyptian and Zambian debt positions and further reduced its Senegalese Eurobond position such that it now represents an immaterial holding within the Fund. Senegal has been the largest year-to-date detractor from the Fund following further revelations about the government's hidden debt situation. The new administration under President Faye revealed last year that the 2023 fiscal deficit had been understated by 5% of gross domestic product (GDP), after which the Fund reduced its debt position once market prices normalised. Since then, a formal debt audit has revealed that the situation is far more egregious than initially revealed, and that the previous administration had in fact intentionally misled investors since 2019 – under-recording deficits by 5% to 7% of GDP per annum. By 2023, government debt stood at roughly 100% of GDP versus the 74% that was falsely reported. This not only breaks investor trust but also calls into question the sustainability of Senegal's growth trajectory, which has been revealed as a debt-fuelled model that may have sunk capital into unproductive projects.

## Share price

Share prices are calculated on a net asset value basis, which is the total market value of all assets in the Fund, including any income accruals, less any permissible deductions from the Fund, divided by the number of shares in issue. Forward pricing is used. The weekly price of the Fund is normally calculated each Friday. Purchase requests must be received by the Registrar of the Fund by 17:00 South African time on that dealing day to receive that week's price. Redemption requests must be received by the Registrar by 17:00 South African time on the dealing day on which shares are to be redeemed to receive that week's price. Share prices are available on www.allangray.co.za.

#### Fees and charges

Permissible deductions from the Fund may include management fees, brokerage, securities transfer tax, auditor's fees, bank charges and custody fees. A schedule of fees, charges and maximum commissions is available on request from the Representative.

### Total expense ratio (TER) and transaction costs

The TER is the annualised percentage of the Fund's average assets under management that has been used to pay the Fund's actual expenses over the past one- and three-year periods. The TER includes the annual management fees that have been charged (both the fee at benchmark and any performance component charged and other expenses like audit fees. Transaction costs (including brokerage, securities transfer tax and investor protection levies where applicable) are shown separately. There are no explicit brokerage charges in global bond markets. The broker rather takes an undisclosed spread between the purchase and sale price. The spread (charge) can vary from negligible to substantial depending on the asset and market circumstances. The disclosed transaction charge is therefore zero but in reality, there are transaction costs which reflect in the Fund's returns. We aim to minimise costs by keeping our trading activity to a minimum and always seeking out the most favourable price when buying and selling assets. Transaction costs are necessary costs in administering the Fund and impact buying and senting assets. If ansaction costs are necessary costs in administrance in the initial manager. Fund returns. They should not be considered in isolation as returns may be impacted by many other factors over time, including market returns, the type of fund, the investment decisions of the Investment Manager and the TER. Since Fund returns are quoted after the deduction of these expenses, the TER and transaction costs should not be deducted from published returns. As collective investment scheme expenses vary, the current TER cannot be used as an indication of future TERs. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. Instead, when investing, the investment objective of the Fund should be aligned with the investor's objective and compared against the performance of the Fund. The TER and other funds' TERs should then be used to evaluate whether the Fund performance offers value for money. The sum of the TER and transaction costs is shown as the total investment charge (TIC).

#### African markets

The Investment Manager retains the right to distribute all or part of any redemption proceeds in specie (in kind).

#### Fair value pricing

The board of directors of the Fund (the "Board") may fair value the Fund's assets in accordance with the Board's fair value pricing policies if: 1) the closing market quotations or official closing prices are not readily available or do not accurately reflect the fair value of a Fund asset; or 2) the value of a Fund asset has been materially affected by events occurring before the Fund's pricing time but after the close of the exchange or market on which the asset is principally traded. The Board delegates the responsibility for fair value pricing decisions to a valuation committee of the Investment Manager.

## Contractual risk

The Fund can use derivatives to manage its exposure to currencies and/or interest rates and this exposes the Fund to contractual risk. Contractual risk includes the risk that a counterparty will not settle a transaction according to its terms and conditions because of a dispute over the terms of the contract (whether or not bona fide) or because of a credit or liquidity problem, causing the Fund to suffer a loss. Such contract counterparty risk is accentuated for contracts with longer maturities where events may intervene to prevent settlement, or where the Fund has concentrated its transactions with a single or small group of counterparties.

#### Derivatives

Borrowing, leveraging and trading securities on margin will result in interest charges and, depending on the amount of trading activity, such charges could be substantial. The low margin deposits normally required in futures and forward trading, which the Fund may utilise, permit a high degree of leverage.
